Access procedure for Webinars:

2. If you see a topic that interests you, please check <http://www.mn-sea.org/calendar/> to make sure the webinar is not already being hosted at another member firm.

Please also include following information, which will be posted on <http://www.mn-sea.org/calendar/> page for others to attend if interested. All webinars must be reserved at least two week in advance of the event.

- a. Address where the webinar will be hosted.
 - b. Name/Location of conference room.
 - c. Contact name, e-mail and phone number for the person who will start and coordinate the webinar.
 - d. Any site specific information such as parking/access etc.
4. An e-mail explaining how to join the webinar will be sent to you.
5. Multiple people can watch the webinar at the same time in the same location.
6. MNSEA will advertise the webinar you selected to be hosted at your location.
